OTHER OBJECTS:

(OBJECTS INCIDENTAL OR ANCILLARY FOR THE ATTAINMENT OF THE MAIN OBJECTS).

- (a) To accept donations, grants, presents and other gifts and deal with the same for the purpose of the Trust. To acquire movable and immovable properties by purchase, lease or otherwise and to construct buildings on the land thus purchased for the purpose of the Trust.
- (b) To invest the Trust funds or deal with the same as the Trustees may deem fit, to carry on the objects of the Trust effectively.
- (c) To enter into any arrangement with any government authorities whether Central, State, Local, Municipal or otherwise in pursuance of the objects of the Trust to obtain from any such government authority all rights, concessions, privileges that may deem conducive to the Trust's objects.
- (d) To pay the costs, charges and other expenses preliminary and incidental to the formation, establishment and registration of the Trust.
- (e) Generally to do all such other things as are incidental or conducive to the attainment of the above objects.

VESTS IN THE TRUSTEES:

The founder doth hereby transfer a sum of Rs.30, 000 (Rupees Thirty Thousand Only) as aforesaid in favour of the Trustees and unto the Trustees thereof. The Trustees shall hold the said fund other properties that may be endowed or conferred for the said Trust for the use and benefit of the Trust. The Trustees shall invest the Trust funds in government securities or other securities authorized by law for the investment of the Trust funds and in particular keeping in view the provisions of the Income Tax Act 1961 and any amendments thereto.

TRUSTEES QUALIFICATION DUTIES & POWERS:

- 1) **QUALIFICATION:** The Trustee shall be a person
 - a. Who has accepted whole heartedly the faith and conviction of the Trust and
 - b. Who has a good standing in the society above reproach, self-controlled, temperate and not addicted to any harmful habits like, tobacco, drugs or drinks and not convicted of an offense involving moral turpitude.

- c. The Trust no.1 will be the successor to-officiate the office as Managing Executive Director of the said Trust, after the expiry of the said incumbent's term/sudden demise/deportation if occur/necessitate, and if Trustee No. 1/desire, can appoint any interested family member of the author as Managing Director / Executive Director during incumbents term of the Trustee.

2) POWERS & DUTIES:

- a) The Trustees may out of the corpus of the subject matter of the Trust, spend money or part thereof for capital or revenue expenditure as may be decided by the Trustees.
- b) The Trust funds shall consist of the Trust money hereby created and all donation and income received and such future contribution that may be made to the Trust.
- c) Subject as aforesaid the Trustees shall from time to time make and alter rules and regulations with regard to the conduct of the business and all matters in respect of which any power of duty is hereby vested in them as they may think proper.
- d) The Trustees shall not receive any remuneration for administration of the Trust or except the Managing Trustee for as full time service as the Executive Director. Any out of pocket expenses incurred by any Trustee for the Trust can be reimbursed from the Trust funds.
- e) The Trustees shall frame rules for the administration of the Trust and their management and shall have the power to modify them from time to time, as the exigencies of the situation require.
- f) The Trust may receive donations of money and or properties when received shall be at the absolute disposal of the Trust.
- h) The Board may by resolution extend the activities of the Trust or undertake any activity in furtherance of the main objects of the Trust.
- i) The Trustees shall maintain the minutes book in which the proceeding of all meetings of the Trustees shall be recorded by the Trustees and the same shall be signed by the Chairman of the meetings.

- k) The Trustees may maintain a set of advisors for the purposes of utilizing their services in furtherance of the objects of the trust.

3) MEETINGS OF THE BOARD OF TRUSTEES:

- a) The Board shall hold an annual meeting mainly for the purpose of approving the audited statement of accounts and the report of the secretary about the working of the Trust during the previous year.
- b) The Board shall also transact any business that may be specified in the Agenda or otherwise agreed to by the Board of Trustees.
- c) The Board shall appoint an Auditor at the annual meeting for the subsequent year.
- d) The quorum for the meeting is $1/3^{\text{rd}}$ of its total number of Trustees subject to a minimum of three Trustees.
- e) All decisions shall be carried out by the Board.
- f) Any decision in writing signed by all the Trustees shall be binding on the board as though it has been passed at a meeting of the Board of Trustees.
- g) The meeting of the Board shall be convened after giving at least twenty one days unless there is need to convene the meeting of special or emergency nature.

- a) The first Trustee of the Trust herein contained shall be called as the Founder Trustees and she shall hold office for life.
- b) **MARIA KUMAR METHARI**, the 1st Trustee herein contained shall be the Managing Trustee / Executive Director for life.
- c) The Trustees may if he/she so desires resign his/her Trusteeship, even before the expiry of the term of Trusteeship.

5) MANAGING TRUSTEE / EXECUTIVE DIRECTOR:

The Board of Trustees may delegate their power to the Executive Director to carry on the routine management of the affairs of the Trust.

- a) The Executive Director is entitled for remuneration / salary for the full time services rendered to the Trust as agreed by the Trustees. The Executive Director shall have the following power.
- b) To appoint all the necessary staff for the management of the programme of the Trust and to fix their remuneration and service conditions, subject to service rules prescribed by the Trustees.
- c) To open Bank accounts for the trust.
- d) To enforce, resist, allow, remit set off or compromise or to refer to arbitration any claim by or against the Trust.
- e) To institute and carry on or discontinue and to defend legal proceedings in relation to the Trust and for the Trust and for the said purpose or purposes to sign, execute, verify and file any complaint, written statement, application, claim or objection as may be necessary.
- f) To appoint Advocate, Pleaders, or Attorneys for any or all of the purpose stated in the clause (c) and (d) thereof. To demand, receive, take, transfer of and recover or allow on account of any money or moneys or property belonging to the Trust and to give effective receipts and released and in a proper case indemnities for or in respect of any money or property so received or allowed in account by or transferred or delivered to the Trust.
- g) To draw, accept, endorse, give, make or negotiate, cheques, bills, notes, guarantee or other security whether of the State or Central Government for any of the purposes aforesaid.

- h) To execute, do or conduct in or cause to be executed and done all such deeds, instrument and things in relation to the Trust and for the said purpose to sign, execute, endorse or transfer any deed or instrument of thing and to present the same for registration before any registering authorities.

There are no movable/immovable properties in the name of the trust as on the date of execution of this deed except the corpus fund.

6) CHAIRPERSON:

The Trustees, may as and when they deem necessary appoint a chairperson among themselves to preside over the meetings of Trustees for such time as the deem fit. The chairperson will have the casting vote.

7) ACCOUNTS AND AUDIT:

The Accounts of the Trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statement of accounts shall be placed before the Board for its approval within six months of the close of the financial year.

8) BANK ACCOUNTS:

To open a bank account in the name of the Trust and the same shall be operated by **MARIA KUMAR METHARI**, the **Managing Trustee/Managing Director**.

9) CUSTODY OF DOCUMENTS:

The Managing Executive Director Trustee or his nominee or any other Trustee if so authorized by the Board of Trustee shall have the custody of all the documents, deeds of title relating to the Trust properties movable or immovable and investments made and the books of account and other records relating to the Trust and shall be responsible for the preservation of the same.

10) AMENDMENT TO THE TRUST DEED:

Though this Trust shall be irrevocable, the Board may amend the clause relating to the membership and management of the Trust at a duly convened meeting of the Board by a special resolution passed by a 3/4th majority.

1. The funds of the institution would be invested as per section 11(5) of the I.T. Act, 1961.

3. The accounts would be maintained regularly and would be audited by a Chartered Accountant.
4. The funds of the Trust would be utilized only towards the objects and no portion of it would be distributed in any manner to the trustees or persons defined in section 13(1)(c) of the I.T. Act, 1961.
5. In the case of winding up/dissolution of trust/society, the net funds/assets would be transferred to a trust/society having similar objects and enjoying exemption u/s.12A and approval u/s.80G.
6. The benefit of the objects of the Trust/Society would be available to the general public irrespective of caste, creed, Religion or sex.
7. Any amendment to the trust deed/MoA/Bye-laws/Rules & Regulations of the above Trust/society would be carried out only with the prior approval of the Commissioner of Income Tax.
8. The Charitable activities should be confined to the territory of India only.

11) ADVISORY BODY:

The Trustees shall maintain a set of advisors for the purpose of utilizing their services in furtherance of the objects of the Trust.

12) IRREVOCABILITY:

It is declared that the Trust is irrevocable. If the Trust fails for any reason, in the opinion of the Trustees, the net assets of the Trust both movable and immovable shall be handed over to any other Trust having the same / similar objects as decided by the majority of the Trustees.

13) GENERAL:

- a. The Trust shall utilize the income and funds of the Trust solely towards the objects of the Trust herein contained and no portion of its shall be utilized for payment to the Trustees by way of profit, interest dividend or otherwise.
- b. The Trust shall confine its activities only within the territories of India and no activity of the Trust shall be carried out outside India.
- c. The Trust shall not carry out any activity with the intention of earning a profit.
